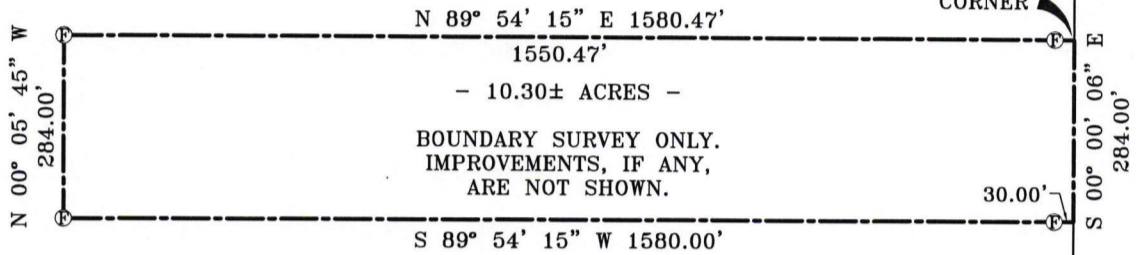

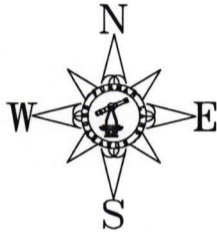

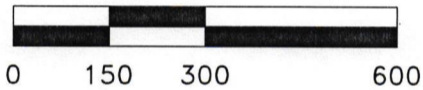

Survey, Carson County, Texas, being a portion of that certain 312.56+/- acre tract of land being described in that certain instrument recorded under Clerk's File No. 2023-00000390 of the Official Public Records of Carson County, Texas, said 10.30+/- acre tract of land having been surveyed on the ground on April 14, 2023 by Furman Land Surveyors, Inc. and being described by metes and bounds as follows:

COMMENCING at a 3/8 inch iron rod found, of record, in the East line of said Section 48, for the Northeast corner said 312.56+/- acre tract of land;

THENCE S. 00° 00' 06" E. 893.94 feet along the East line of said Section 48 to the Northeast and BEGINNING CORNER of this tract of land;

THENCE S. 00° 00' 06" E. 284.00 feet along the East line of said Section 48 to the Southeast corner of this tract of land, from whence a 3/8 inch iron rod found, of record, for the Southeast corner of said Section 48 bears S. 00° 00' 06" E. 1400.00 feet;

THENCE S. 89° 54' 15" W., at 30.00 feet pass a 1/2 inch iron rod with cap stamped "FURMAN RPLS" set, continuing for a total distance of 1580.00 feet to a 1/2 inch iron rod with cap stamped "FURMAN RPLS" set for the Southwest corner of this tract of land;

THENCE N. 00° 05' 45" W. 284.00 feet to a 1/2 inch iron rod with cap stamped "FURMAN RPLS" set for the Northwest corner of this tract of land;

THENCE N. 89° 54' 15" E., at 1550.47 feet pass a 1/2 inch iron rod with cap stamped "FURMAN RPLS" set, continuing for a total distance of 1580.47 feet to the PLACE OF BEGINNING and containing 10.30+/- acres of land, more or less.
