Survey, Carson County, Texas, being a portion of that certain 312.56+/- acre tract of land being described in that certain instrument recorded under Clerk's File No. 2023-00000390 of the Official Public Records of Carson County, Texas, said 10.32+/- acre tract of land having been surveyed on the ground on August 22, 2023 by Furman Land Surveyors, Inc. and being described by metes and bounds as follows:

COMMENCING at a 3/8 inch iron rod found, of record, for the Southeast corner of said Section 48;

THENCE S. 89° 54' 15" W. 2318.34 feet along the South line of said Section 48 to the Southeast and BEGINNING CORNER of this tract of land;

THENCE S. 89° 54' 15" W. 281.00 feet along the South line of said Section 48 to the Southwest corner of this tract of land, from whence a 3/8 inch iron rod found, of record, for the Southwest corner of said Section 48 bears S. 89° 54' 15" W. (Base line) 2681.45 feet;

THENCE N. 00° 05' 45" W., at 30.00 feet pass a 1/2 inch iron rod with cap stamped "FURMAN RPLS" set, continuing for a total distance of 1400.00 feet to a 1/2 inch iron rod with cap stamped "FURMAN RPLS" set for the Northwest corner of this tract of land;

THENCE N. 89° 54' 15" E. 361.00 feet to a 1/2 inch iron rod with cap stamped "FURMAN RPLS" set for the Northeast corner of this tract of land;

THENCE S. 00° 05' 45" E. 700.00 to a 1/2 inch iron rod with cap stamped "FURMAN RPLS" set;

THENCE S. 89° 54' 15" W. 80.00 feet to a 1/2 inch iron rod with cap stamped "FURMAN RPLS" set for an interior corner of this tract of land;

THENCE S. 00° 05' 45" E., at 670.00 feet pass a 1/2 inch iron rod with cap stamped "FURMAN RPLS" set, continuing for a total distance of 700.00 feet to the PLACE OF BEGINNING and containing 10.32+/- acres of land, more or less.
